I/WE UNDERSTAND THAT SKATEBOARDING AND ANY OTHER ACTIVITIES CARRIED OUT AT THE SKATEPARKS IN THE TOWN OF HALTON HILLS NECESSARILY INVOLVE KNOWN AND UNKNOWN RISKS OF INJURY TO ME AND OTHER PEOPLE IN WHICH PARTICIPANTS MAY SUFFER SERIOUS INJURY OR FATALITY.

I/WE FURTHER UNDERSTAND THAT THE RISK OF INJURY MAY ARISE FROM A VARIETY OF SOURCES INCLUDING BUT NOT LIMITED TO TERRAIN, EQUIPMENT, FACILITIES, TEMPERATURE, WEATHER, CONDITION AND ACTIVITIES OF PARTICIPANTS, SPECTATORS, OFFICIALS, AND EVENT PERSONNEL.

I/WE HEREBY ASSUME ALL RISKS ASSOCIATED WITH ATTENDANCE AT OR PARTICIPATION IN EVENTS AT PUBLIC SKATEPARKS WITHIN THE TOWN OF HALTON HILLS, INCLUDING ORGANIZED COMPETITION, TRAINING, EDUCATION AND ALL ACTIVITIES ASSOCIATED WITH SKATEBOARDING, SCOOTER RIDING, BMX, INLINE SKATING, AND ANY OTHER ACTIVITIES CARRIED OUT AT THE SKATEPARK.

I/WE HEREBY WAIVE ANY RIGHTS THAT MIGHT ACCRUE TO ME OR TO ANYONE ON WHOSE BEHALF I/WE AM SIGNING THIS WAIVER, INCLUDING A CHILD EITHER BY VIRTUE OF COMMON LAW, THE OCCUPIERS' LIABILITY ACT (ONTARIO) OR ANY OTHER STATUE IN FORCE FROM TIME TO TIME, TO SUE FROM DAMAGES SUSTAINED: A) AS A RESULT OF INJURY SUSTAINED OFF

SITE OR ON THE PREMISES OF THE TOWN OF HALTON HILLS; B) DURING MY PARTICIPATION IN ANY EVENT OFF SITE OR ON THE PREMISES OF THE TOWN OF HALTON HILLS; AND, C) AS A RESULT OF THE USE OF ANY EQUIPMENT BELONGING TO DRIVEWAY SKATESHOP WHETHER OR NOT THE INJURY ARISES AS A RESULT OF THE NEGLIGENCE OF DRIVEWAY SKATESHOP, IT'S EMPLOYEES, AGENTS OR VOLUNTEER PARTICIPANTS. IN THE EVENT OF AN INJURY, DRIVEWAY SKATESHOP WILL TAKE ALL REASONABLE STEPS TO CONTACT PARENT/GUARDIAN. IN THE EVENT THAT DRIVEWAY SKATESHOP IS UNABLE TO CONTACT PARENT/GUARDIAN, PARENT/GUARDIAN AUTHORIZES DRIVEWAY SKATESHOP TO CONTACT SUCH MEDICAL EMERGENCY PERSONNEL AS DRIVEWAY SKATE SHOP MAY THINK NECESSARY.

I/WE FURTHER AGREE TO INDEMNIFY AND HOLD HARMLESS DRIVEWAY SKATESHOP AND THE TOWN OF HALTON HILLS FROM ANY CLAIMS MADE BY OR THROUGH ME BY THIRD PARTIES AGAINST DRIVEWAY SKATESHOP AND THE TOWN OF HALTON HILLS.

I/ WE FURTHER WARRANT THAT , IF I/WE AM SIGNING THIS WAIVER ON BEHALF OF A CHILD UNDER THE AGE OF 18 YEARS, I/WE AM A PARENT OR LEGAL GUARDIAN OF SUCH CHILD AND AM LEGALLY ENTITLED TO SIGN SUCH WAIVER.
